Org. Setting and Reporting

The United Nations Environment Programme (UNEP) is the leading global environmental authority that sets the global environmental agenda, promotes the coherent implementation of the environmental dimension of sustainable development within the United Nations system and serves as an authoritative advocate for the global environment. This position is located in UNEP's Science Division which is responsible for analyzing the state of the global environment, providing early warning information and assessing global and regional environmental trends to catalyze and promote international cooperation and action on the environment.

Under the overall direction of the Chief of the Capacity Development and Innovation Branch and direct supervision of the Head of Sustainable Development Goals (SDGs) and Environment Statistics Unit, the incumbent will contribute substantively to the work related to dissemination and uptake of the global SDG indicator methodologies through targeted capacity development for key SDG indicators at the national and regional level, integrated analysis of progress towards agenda 2030; and tracking progress on the voluntary commitments towards a Pollution-Free Planet. The Division works closely with a large number of partners and collaborating centres in all regions of the world, and has established functional networks for data, information, assessments and capacity development. The incumbent will be responsible for the following duties:

Responsibilities

- Participates in the development, implementation and evaluation of assigned programmes/projects, etc.; monitors and analyzes programme/project development and implementation; reviews relevant documents and reports; identifies problems and issues to be addressed and proposes corrective actions; liaises with relevant parties; identifies and tracks follow-up actions.
- Researches, analyzes and presents data and information gathered from diverse sources, including data visualization and analysis:
- a) Coordinates the development of indicators and analysis on pollution, towards a Pollution-Free Planet.
- b) Organizes, design, plan and carry out the collection, evaluation, analysis, compilation and dissemination of statistical data related to pollution.
- Assists in policy development, including the review and analysis of issues and trends, preparation of evaluations or other research activities and studies:
- a) Prepares various written outputs, e.g. draft background papers, analysis, sections of reports and studies, inputs to publications, etc.
- b) Provides substantive support to consultative and other meetings, conferences, etc., to include proposing agenda topics, identifying participants, preparation of documents and presentations, etc.
- Undertakes outreach activities; conducts training workshops, seminars, etc.; makes presentations on assigned topics/activities.

A minimum of five (5) years of progressively responsible experience in project or programme management in the context of information management and complex socio-economic settings, is required. Experience in working on projects operating at the science-policy interface, is desirable.

Languages

English and French are the working languages of the United Nations Secretariat. For the post advertised, fluency in oral and written English is required. Knowledge of another official United Nations language is an advantage.

Assessment

Evaluation of qualified candidates will include an assessment exercise which may be followed by competency-based interview.
